Subject: Response to Four 692 (SC/CG) Letters Dated September 25, 2009
Tax Years: 2003, 2004, 2005 and 2006

Dear Ms. McGlown:

I received four separate "692 (SC/CG)" computer-generated letters from you, all dated September 25, 2009, alleging that I have a federal income tax liability of \$136,293.33 for tax years 2003, 2004, 2005 and 2006, as summarized below:

I'm afraid we have a serious disagreement. You claim that I have a federal income tax liability for those tax years, and I claim that I don't.

As I mentioned in my letter of August 4th, I have been involved in this dispute with the IRS for a number of years now. More than once, I have given the IRS extensive documentation to support my position that I have no federal income tax liability, but it has chosen to ignore it. And, throughout this entire ordeal, the silence and evasion exhibited by IRS employees clearly demonstrates a pattern of bad faith dealing.

Consistent with that pattern of behavior, I noticed that you, like all of the other IRS employees before you, refused to complete, sign and return the "**Affidavit of Authority**", attached to my previous letter. That's no problem. You will have the opportunity to provide that information at a later date.

Ms. McGlown, consider yourself put on **NOTICE** that every letter, email, telephone record and document you produce will become evidence in a court of law and you, along with every other IRS employee who touches this case, will be deposed to testify under oath and under the threat of perjury as to your actions.

For now, I am left with this simple reply to your letter:

I deny that I have a federal income tax liability for calendar years 2003, 2004, 2005 and 2006, or any other calendar year.

Proceed as you will.
