Subject: Response to CP22E Changes to Your 2009 Form 1040A
Tax Year: 2009

Dear Anonymous IRS Employee:

I received an unsigned “CP22E” computer-generated notice from you for tax year 2009. This notice, with the title “Changes to Your 2009 Form 1040A”, stated “As a result of a recent audit, we changed your 2009 Form 1040A”.

The notice was dated June 17, 2013, which I found odd, considering that I received it in the mail on June 13, 2013.

In that notice, you allege that I have a 2009 federal income tax liability of \$54,728.53, as summarized below:

Alleged Amount Due	\$ 54,728.53

On page 2 of the notice were these words: “If we don’t hear from you, we’ll assume you agree with the information in this notice.” Please consider this letter my timely response to the June 17th notice.

I’m afraid we have a serious disagreement. You claim that I have a federal income tax liability for tax year 2009, and I claim that I don’t.

I have been involved in disputes with the IRS for a number of years now. More than once, I have given numerous IRS employees extensive documentation to support my position that I have no federal income tax liability, but they have all chosen to ignore it. Throughout this entire ordeal, the silence and evasion exhibited by IRS employees clearly demonstrates a consistent pattern of bad faith dealing.

But, you can change all of that by answering these three questions:

- 1. What section of the U.S. Code (Title/Subtitle/Chapter/Subchapter/Part) requires me to file an income tax return?**
- 2. In what taxable activity am I engaged that makes me liable for the income tax?**
- 3. Should you fail to provide the answers to Questions 1 and 2 - What section of the U.S. Code gives you the authority to take ANY action against me?**

These are reasonable questions to which any American citizen deserves an answer, especially when faced with the prospect of having his property confiscated by liens and levies, and his freedom taken away by arrest and imprisonment.

Until I receive answers to those questions, I am left with this response to your notice:

- 1. I deny that I am required to file a tax return for calendar year 2009, or any other calendar year.**
- 2. I deny that I have a federal income tax liability for calendar year 2009, or any other calendar year.**
- 3. I do not consent to any person preparing, filing, or signing Form 1040, 1040A, or any other version of the Form 1040 on my behalf and HEREBY OBJECT TO SUCH ACT.**

To you, and every IRS employee who touches this case, please consider yourself put on **NOTICE** that every letter, email, telephone record and document you produce will become evidence in a court of law and you will be deposed to testify under oath and under the threat of perjury as to your actions.

To date, I have extensive correspondence containing irrefutable evidence of multiple counts of provable mail fraud, wire fraud, threats, extortion, conversion, false claims, and conspiracy. All of these are very serious felonies punishable by long prison sentences and very large fines.

Proceed with caution.
