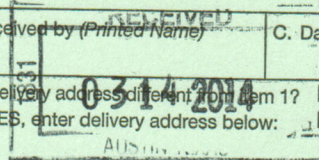

Re. Notice of Revocation of Signature


I hereby revoke and rescind my signature from each and every document I have ever signed that would indicate or provide *prima facie* evidence that I am now or ever was a taxpayer or subject to (liable for) any internal revenue tax whatsoever. Since 2013, I have learned and determined that my signatures on IRS Forms were obtained under conditions of mistake of fact, mistake of law, misrepresentation, fraud, constructive fraud, duress and/or coercion.

1. In years past, I had been influenced and misled by the news media (including IRS press releases), by tax preparers, and by a misinformed public that I was subject to (liable for) internal revenue taxes, and that if I did not file Form 1040 and other IRS forms and documents by the April 15th deadline, I would be subject to a fine and jail sentence.
2. In addition to the aforesaid warnings, companies indiscriminately submitted information returns to the Secretary that claimed I had been paid taxable income. However, they provided no facts or witnesses to support their determinations that the tax laws applied to me, and that what they paid me was reportable to the Secretary as taxable income.
3. I now believe that both the United States Congress and the Internal Revenue Service, by deceptive and misleading words and statements in the Internal Revenue Code, IRS publications and news releases, have deceived me into believing that Congress had imposed a direct unapportioned tax on my earnings and, by such deception, have created the greatest extortion ever perpetrated upon a nation of free people in the entire history of the world.

Based on the foregoing, I hereby exercise my right to rescind, cancel, and to render null and void, from the time of signing, every document containing my signature that would indicate in any manner whatsoever that I was ever subject to (liable for) any internal revenue tax.

I declare under penalty of perjury of the United States of America that I have read the foregoing document and know its contents, and to the best of my knowledge the statements therein are true and correct.
